

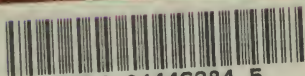

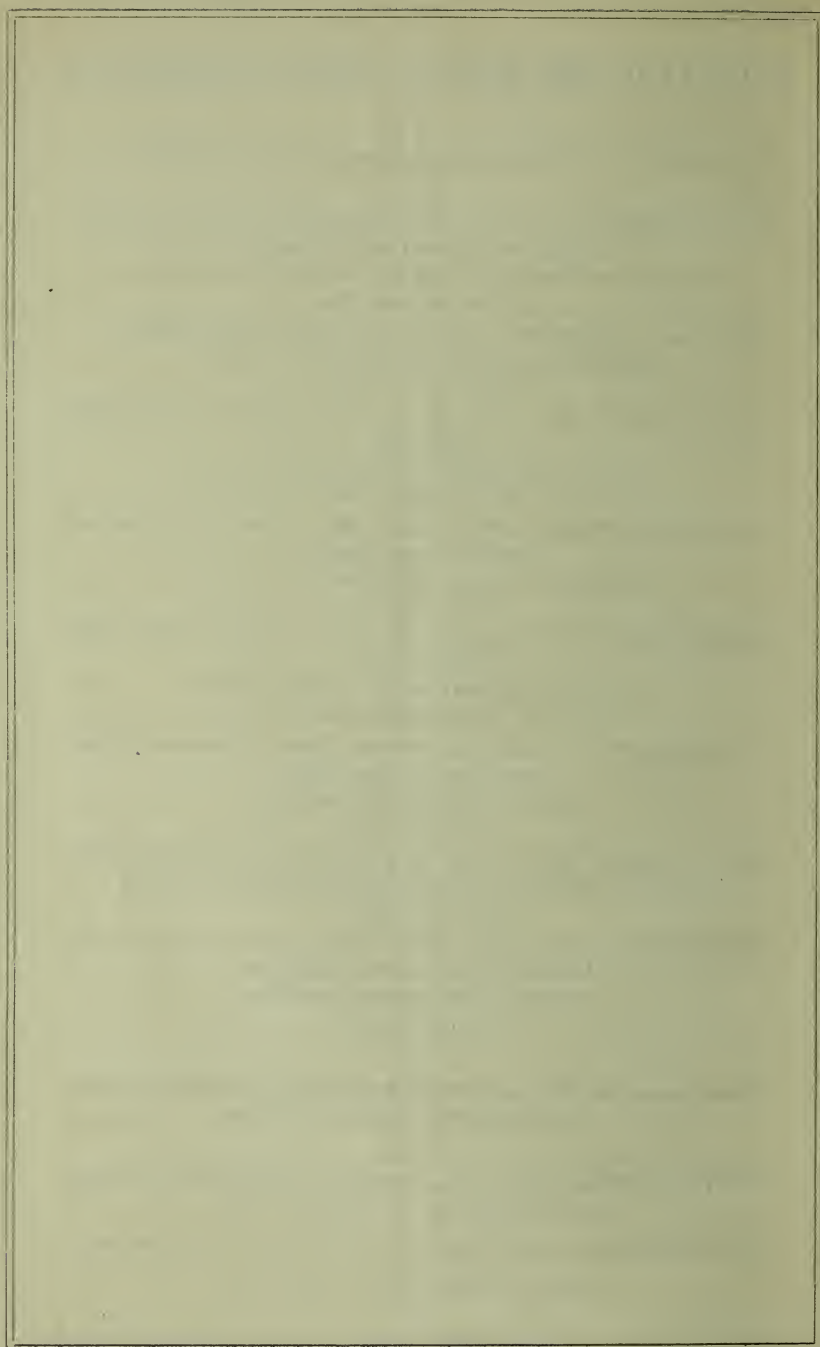

## ANNOUNCEMENT.

---

IN issuing to the Profession and public the announcement of the Twentieth Winter Session of the Toronto School of Medicine, the Faculty have much pleasure in congratulating the friends of the Institution on its continued prosperity—a prosperity indicated not only by a large increase of pupils annually, but by the more general existence among them of those higher preliminary qualifications so very desirable in gentlemen entering upon the study of medicine.

After the close of the last Lecture Season, Dr. Barrett—who for the past ten years had proved himself both a popular lecturer and successful teacher—found that engagements altogether outside of the School necessitated his resignation of the Chair of Institutes of Medicine—a step regretted alike by himself, his colleagues, and the pupils.

As a tribute of respect to his personal worth and scientific attainments, as well as a mark of continued esteem, the Corporation have elected him to the honorary position of Emeritus Lecturer on the Institutes of Medicine.

As future incumbent of the Chair thus vacant, the Corporation has had the good fortune to secure the services of James Bovell, M.D., and L.R.C.P., Eng., a gentleman of more than Provincial reputation, who has devoted many years of studious observation to microscopical anatomy and its important bearings, and is already well known as a favourite teacher in this department.

Lectures will commence on Wednesday the 1st of October next. They will be delivered in the Medical School Building of the Toronto University, situated in University Park.

Students of the Toronto School of Medicine will thus be enabled, from their proximity, to avail themselves of the advantages afforded by the University Library and Museum.

During the past year the Corporation, at great expense, procured an extensive and valuable assortment of anatomical and pathological models and preparations made in Paris. These, together with the previously existing Museum, and which is yearly increasing in value

from additions thereto, and the Medical Museum of the Toronto University (which has been placed in charge of this School) form, in the total, a collection of great value for the purposes of illustration.

THE CHEMICAL LECTURE ROOM AND LABORATORY OF UNIVERSITY COLLEGE are provided with every modern improvement, and the greatest facilities are offered for the study both of Theoretical and Practical Chemistry, under the able direction of Professor Croft.

The arrangements in reference to the study of *Anatomy*, it is believed, are such as to afford the student in this department greater advantages than exist in any other school in British America.

The DISSECTING ROOM, well lighted and ventilated, is amply furnished with material, and under the immediate control of Dr. Lizars, formerly Demonstrator of Anatomy in the University of Edinburgh.

The room will be open from the 1st of September.

The subjects of *Physiology* and *Pathology* will be illustrated by the microscope.

A carefully-selected CABINET OF MATERIA MEDICA, AN HERBARIUM, AND PLATES will enable the lecturer on Pharmacology to fully illustrate his branch.

THE TORONTO LYING-IN-HOSPITAL affords to students who have attended one course on Obstetrics, every facility for the study of Clinical Midwifery. Fees: \$5 for six months, or \$8 for one year.

Two wards have been set apart for the especial treatment of Uterine Diseases.

THE TORONTO DISPENSARY, York Street, is in a prosperous condition. Medical attendants—Drs. Wright, Thorburn, O'Dea, Bull, and Hall.

Pupils may here find many cases of great practical importance.

THE TORONTO GENERAL HOSPITAL.—At this Institution a very large number of the most important Surgical and Medical

cases are annually presented to the observation of Students. Fees : \$8 for six months, \$10 for the year, or \$20 for perpetual ticket.

Operations chiefly on Saturday at 1 P.M.

As the several lecturers are engaged in practice, and reside in Toronto, senior pupils will frequently have the opportunity of witnessing the treatment of accidents and operations in the more private walks of life.

At the University Examination in 1860, seven students of this School obtained Scholarships of the value of \$120 each.

The Gold Medal and four Silver Medals were also carried off by graduating pupils of the Toronto School of Medicine.

In 1861, seven Scholarships, the Gold Medal, and one Silver Medal ; and in April, 1862, the three Scholarships, and two Gold Medals, constituting all the honors awarded by the University, were adjudged to students of this School.

Candidates who can appreciate the importance of an honorable Degree in Medicine, will hardly fail to recognize the propriety of graduating at the Toronto University. To gentlemen who equally value a sound Medical Education as the surest pathway to future eminence in the Profession, but who purpose obtaining license from the Medical Board for Upper Canada, the Toronto School of Medicine affords every educational advantage.

The fee for the Courses on General and Descriptive Anatomy, Surgery, Materia Medica, Practice of Medicine, Midwifery, and Institutes of Medicine, \$12 each (on each of these branches not less than 100 lectures will be delivered) ; Surgical Anatomy, \$4 ; Chemistry and Botany, \$5 each ; Medical Jurisprudence and Demonstration, \$8 each. Registration Fee, \$2. Fees to be paid strictly in advance.

As the several Lectures will commence punctually on the *first* of October, students for the Session are respectfully urged to be then present.

## Extracts from the Statutes of the University of Toronto.

### SCHOLARSHIPS.

Four Scholarships will be annually offered for competition, viz.:—

One for Matriculants.

One for Students of one year's standing.

One for Students of two years' standing.

One for Students of three years' standing.

No Scholarship will be awarded to any Candidate unless he shall have been classed in Honors in at least two-thirds of the Departments comprised in the Examination. Each Scholarship is of the value of thirty pounds a year. Each Scholarship is tenable for one year only, but the Scholars of one year are eligible for the Scholarships of the succeeding year.

Students who have not previously Matriculated in any of the Faculties, may compete for the Scholarships of the first, second, or third years, by taking, along with the subjects prescribed for that year, the subjects appointed for Matriculation.

Every Student taking a Scholarship is required to sign a declaration that it is his intention to pursue his Medical Studies one, two, or three years, according to the year in which he has taken such Scholarship, and proceed to a Degree in the University of Toronto.

#### Subjects of Examination for Matriculation.

[Which Examination may be undergone at any time prior to Examination for a Scholarship in Medicine or for the Degree of M.B.]

LATIN—Sallust, Catilina.

MATHEMATICS—Ordinary Rules of Arithmetic. Vulgar and Decimal Fractions. Extraction of the Square Root. First Four Rules of Algebra. (Colenso's.)

ENGLISH—Grammar and Composition.

HISTORY AND GEOGRAPHY—Outlines of English His-

tory to the present time. (White's History of Great Britain and Ireland.) Outlines of Ancient and Modern Geography. (Schmitz's Manual of Ancient Geography, Anderson's Modern Geography.)

CHEMISTRY—Elements of Chemistry. (Chambers' Educational Course.)

NATURAL HISTORY—Elements of General and Comparative Physiology. (Agassiz and Gould's Comparative Physiology.)

ELEMENTS OF BOTANICAL SCIENCE—Structural and Systematical. (Gray's First Lessons in Botany, Lindley's Classification.)

Candidates for a MATRICULATION SCHOLARSHIP are required, in addition to the above, to undergo Examination in the following subjects:—

GREEK AND LATIN LANGUAGES—Homer, Iliad, B. I. Horace, Odes, B. I. Translation into Latin Prose.

MATHEMATICS—Algebra, as far as Quadratic Equations, inclusive. Euclid, B. I.

FRENCH—Grammar. Voltaire, Histoire de Charles XII.

#### Subjects for Examination for Scholarships.

FIRST YEAR—Anatomy of the Bones, Muscles, and Ligaments, and the Viscera of the Abdomen and Thorax. General Anatomy and Physiology of the Organs of Locomotion, Digestion, and Circulation. Inorganic Chemistry and Heat.

SECOND YEAR—Anatomy. Physiology. Organic Chemistry. and Electricity. Botany. Therapeutics and Pharmacology.

THIRD YEAR—Medicine. Surgery. Midwifery. Medical Jurisprudence. Comparative Anatomy. Practical Chemistry.

#### Subjects of Examination for the Degree of M. B.

DEGREE OF M. B.—Anatomy. Physiology. Practical Anatomy. Theory and Practice of Medicine. Principles and Practice of Surgery, Midwifery, and Diseases of Women and Children. Therapeutics and Pharmacology. Chemistry. Practical Chemistry. Medical Jurisprudence.

### Medals, Prizes, and Certificates of Honor.

- A GOLD MEDAL** will be given to the Student who, at the Examination for the Degree of M.B., shall have been placed First in the First Class; and on the special recommendation of the Examiners.
- SILVER MEDALS** will be given to the Students who, at the Examination for the Degree of M.B., shall have been placed in the First Class of Honors.
- No Medal will be awarded to any Candidate unless he shall have been classed in Honors in all the Departments comprised in the Examination.
- A PRIZE** of the value of Four Pounds, in Books, may be given annually for the best Composition by Students below the standing of B.A., LL.B., or M.B., on some subject to be proposed by the Vice-Chancellor, in each of the following Departments, viz.: Greek Verse, Greek Prose, Latin Verse, Latin Prose, English Verse, English Prose, French Prose, and German Prose.
- THREE PRIZES** of Books, of the value of Six Pounds, Four Pounds, and Two Pounds, respectively, may be given annually for the three best Theses by Candidates for the Degree of M.D.
- CERTIFICATES OF HONOR** will be given to those Students who, at any of the Examinations, have been placed in the First Class in Honors in any Department.

### Examinations.

- The Examination for Matriculation will be held on the 23rd of September.
- Additional Examinations for Matriculation may be held at other periods, but no Honors or Scholarships will be awarded at such additional Examinations.
- The Examinations other than for Matriculation, will be held in the beginning of the month of April.
- Notice will be given annually, in January, of the days on which the Examinations for the year will commence.
- Every Student who proposes to present himself at any Examination, is requested to send to the Registrar, at least three weeks before the day appointed, a paper, according to a printed form to be

provided, stating the Faculty in which he is a Candidate, his standing, and whether he is a Candidate for Honors or otherwise.

### Degree of M. B.

The following are the requisites for admission to the Degree of Bachelor of Medicine, viz. :—

(1.) Having Matriculated in the Faculty of Medicine, or having Matriculated and passed one other Examination in either of the Faculties of Law or Arts.

(2.) Being of the full age of twenty-one.

(3.) Having pursued Medical Studies for the period of at least four years; and having regularly attended Lectures in the following branches of Medical Education, for the respective periods hereinafter set forth :

*Anatomy*—Two Courses of Six Months.

*Practical Anatomy*—Two Courses of Six Months.

*Principles and Practice of Medicine*—Two Courses of Six Months.

*Principles and Practice of Surgery*—Two Courses of Six Months.

*Chemistry*—Two Courses of Six Months.

*Physiology*—Two Courses of Six Months.


*Midwifery and Diseases of Women and Children*—Two Courses of Six Months, or one Course of Six Months, together with Certificates of having assisted at twelve cases of Labour.

*Therapeutics and Pharmacology*—One Course of Six Months.

*Practical Chemistry*—One Course of Three Months.

*Medical Jurisprudence*—One Course of Three Months.

(4.) Having attended, for at least twelve months, the practice of some General Hospital, and having attended, for at least six months, Clinical Lectures on Medicine and Surgery.

 The Degree of M.B. entitles to the Provincial License.

### Degree of M. D.

The following are the requisites for admission to the Degree of M.D., viz. :—

Having been admitted to the Degree of M.B.; being of one year's standing from admission to the Degree of M.B.; and having composed an approved Thesis upon some Medical subject.
